Live to Shine Collective - A Private Ministerial Membership Association MEMBERSHIP APPLICATION

By joining Live to Shine Collective, a private ministerial membership association (hereinafter, the "Ministry") and/or any website or social media group started by, created by, maintained or organized by the Ministry, I agree to the following terms and conditions:

- 1. This Ministry of members declares that our objective is to allow the Private Membership Ministry founders and all Private Membership Ministry members with a platform in which to conduct all manner of private business with the Ministry and with other Ministries and Ministry members, keeping all business in the private domain and utilizing the protections guaranteed by the Universal Declaration of Human Rights (UDHR), the Constitution of the United States of America to conduct business in private and to provide a platform for members to conduct business in the private domain under all protections acknowledged and guaranteed by the Constitution of the United States, and any previous protections guaranteed.
- 2. We believe that the Universal Declaration of Human Rights (UDHR), the Constitution of the United States of America and the Charter of Rights of Canada guarantees our members the rights to freedom of religion, free speech, petition, assembly, and the right to gather together for the lawful purpose of helping one another in asserting our rights protected by those Constitutions, Charter and Statutes, in addition to the rights to be free from unreasonable search and seizure, the right to not incriminate ourselves, and the right to freely exercise all other unalienable rights as granted by God and guaranteed by those Constitutions, Charter, and Statutes.

WE HEREBY Declare that we are exercising our right of "Freedom of Association" and the "Freedom of Religion" as guaranteed by the Universal Declaration of Human Rights(UDHR), the U.S. Constitution and equivalent provisions of the various State Constitutions, as well as the Charter of Rights of Canada. This means that our Ministry activities are restricted to the private domain only and outside of the jurisdiction of government entities, agencies, officers, agents, contractors, and other representatives as provided by law.

- 3. We declare the basic right of all of our members to decide for themselves which Ministry members could be expected to give wise counsel and advice concerning all matters including, but not limited to spiritual, physical and mental health assistance, law, and any other matter to accept from those members any and all counsel, advice, tips, whom we feel are able to properly advise and assist us.
- 4. We believe that the Almighty God created natural medicine and therapies to attend to the physical, mental and spiritual aspects of health and gave mankind insight for good health through the inspired Word in the Holy Blble. The mission of our Ministry is to provide members with education and resources to follow the Bible and fulfill their responsibility to be good stewards of their physical bodies.
- 5. We expect the freedom to choose and perform for ourselves the types of therapies and treatments that we think best for treating and preventing illness and disease and for achieving and maintaining optimum wellness, as well as the freedom to choose for ourselves any types of assistance which may be made regarding law and any other business activity.

- 6. The mission of this Ministry is to provide members with a forum to conduct business between members in the private domain with the protections guaranteed within the aforesaid Constitution and Charter remaining fully intact.
- 7. The Ministry will recognize any natural person who have joined this Ministry or any online group organized, created, or managed by this Ministry and is in agreement with these principles and policies as a member of this Ministry, providing said person has not been sanctioned or banned by the Ministry, and will provide a medium through which its individual members may associate for actuating and bringing to fruition the purposes heretofore declared.
- 8. Membership to this Ministry, "Live to Shine Collective", and any of its groups may be terminated by the association President or their designee, at any time, should they conclude that a specific member is interacting with them or any other members in a way that is contrary or detrimental to the focus, principles, and betterment of this Ministry.
- 9. I understand that, since the Ministry is protected by the First and Fourteenth Amendments to the U.S. Constitution, it is outside the jurisdiction and authority of Federal and State Agencies and Authorities concerning any and all complaints or grievances against the Ministry members or other staff person. All rights of complaints or grievances will be settled by a Ministry designee, committee, or tribunal and will be waived by the member for the benefit of the Ministry and its members. By agreeing to this membership form I agree that I have sought sufficient education to determine that this is the course of action I want to take for myself.
- 10. I agree to join Live To Shine Collective, a private membership association under common law, whose members seek to help each other achieve better health and good quality of life. As such, I am voluntarily changing my capacity from that of a public person to that of a private member.
- 11. My activities within the Ministry are a private contractual matter that I refuse to share with the Local, State or Federal investigative or enforcement agencies. I fully agree not to pursue any course of legal action against a fellow member of the Ministry, unless that member has exposed me to clear and present danger of substantive evil; and even then, only upon recommendation and approval of the Ministry, which shall not be unreasonably withheld.
- 12. I enter into this agreement of my own free will without any pressure or coercion, I affirm that I do not represent any Local, State or Federal agency whose purpose is to regulate and approve products, or to carry out any mission of enforcement, entrapment or investigation. I have read and understood this document, and my questions have been answered fully to my satisfaction. I understand that I can withdraw from this agreement and terminate my membership in this association at any time, and that my membership can and will be revoked if I engage in abusive, violent, menacing, destructive or harassing behavior towards any other member of the Ministry.

Live to Shine Collective Statement of Faith is as follows:

(verses referenced from the New King James version of the Bible)

- 1. We believe God created the heavens and earth and all that is; the Bible is God's inspired Word. The Bible is the instruction manual from which all law, rights, responsibilities, and instructions for health and salvation of mankind originate. (Genesis 1; 2 Timothy 3:16-17; John 1:1)
- 2. We believe there is only one God who eternally exists in three persons: Father, Son and Holy Spirit. (Matthew 28:19)
- 3. We believe Jesus Christ is God, in His virgin birth, His sinless life, His miracles, His death that paid for our sin through His shed blood, His bodily resurrection, His ascension/rising up to the right hand of the Father and in His personal return in power and glory. (John 1:1; Matthew 1:18,25; Hebrews 4:15; Hebrews 9:15-22; 1 Corinthians 15:1-8; Acts 1:9-11; Hebrews 9:27-28)
- 4. We believe salvation is a gift received by faith alone in Christ alone and expressed in the individual's repentance, recognition of the death of Christ as full payment for sin, and acceptance of the risen Christ as Savior, Lord, and God. (John 14:6; Romans 10:9-10; John 3:16)
- 5. We believe in the present ministry of the Holy Spirit, who lives within and guides Christians so they are enabled to live godly lives. (John 14:15-26; John 16:5-16; Ephesians 1:13-14)
- 6. We believe man is made in the image of God. That man is body, mind and spirit created by God. Restoring health needs to address the whole person--body, mind and spirit. Our bodies are to be used in service to Him. (1 Thessalonians 5:23, Genesis 1:27; Romans 12:1-2; 1 Corinthians 6:19-20)
- 7. God created all that is and gave mankind natural substances and instruction through His Word, the Bible, to attend physical, mental and spiritual health. (Genesis 1:29; Ezekiel 47:12; Psalm 104:14)
- 8. We believe Christ appointed believers to go forth and heal the sick. This remains a privilege and responsibility for all generations. Believers are therefore divinely appointed to establish control over and regulate the application of the Creator's medicine. (Matthew 10:8, Mark 16:17-18)
